	There were no absences to report.					
23/173	Minutes of previous meeting:					
	RESOLVED that the minutes of the meeting held on 23 January 2023, pages 21029-21030 be

	Cllrs Winter and Gott declared an interest in item 5a) on the agenda as the agenda and applicant

23/175	Public Participation:					
	a) The police reports were not as regular as they should be currently. It is hoped that this will					
	change once the new area teams have been established.b) Cllr Battye reported that Westmorland and Furness Council was ready to go and that the					
	transition should appear seamless. Locality boards will be set up and Cllr Battye is very keen to					
	work closely with Town and Parish Councils in her area. It is hoped that Clirs will be given a					
	similar Locality Budget to the one they had under SLDC.					
	It was proposed by the Chair that we move to item 8 on the agenda whilst Cllr Battye was in					
	attendance and it was RESOLVED to do this.					
23/176	Gatebeck 20mph Speed Limit:					
_0, 170	Both the Clerk and Cllr Battye had received representations from residents in Gatebeck regarding					
	the continuing speeding of motorists through the 20mph zone. Cllr Battye reported that she had					
	been in Gatebeck recently and had witnessed the speeding for herself.					
	The Clerk noted that speed data tubes had been installed in early December just as snow fell and					
	turned to ice which would automatically slow drivers down and the data would be useless.					
	It was RESOLVED to contact Cumbria Highways to ask them to install data tubes again as well as					
	communicating with employers on Gatebeck Industrial Estate to speak to their employees as it was					
	noted that a lot of the speeding is around 5pm.					
	Other traffic calming measures such as speed humps and Speed Indication Devices could be					
	considered in the future as well as the construction of an already approved footpath from the					
	crossroads to Barkers with some funding possibly being provided by the Parish Council.

	SL/2023/0172 at Sillfield Farm, Gatebeck - Proposed replacement of lawful, unfettered, residential					
	caravan by permanent dwelling.					
	RESOLVED that the council had no objections to this proposal.					
	PN/2023/0037 at Land at Preston Patrick - Application to determine if prior approval (proposed) is					
	required for a development by or on behalf of an electronic communications code operator for					
	proposed removal of 1 telecommunication mast (18m in height) and the consolidation of equipment					
	on to 1 25m lattice tower. The new tower will include the relocation of 6 antenna to 1 and 2 600mm					
	dish antenna, attached to new headframe which will be attached to 1 proposed 25m tower, the					
	erection of the perimeter fence and ancillary development thereto					
	RESOLVED to support this application as it will provide much needed better coverage.
